The Beresford City Council met in regular session in City Council Chambers at 7:00 p.m. The pledge of allegiance was recited.

<u>Adopt Agenda</u>: A motion to adopt the agenda as presented was made by Seeley, second by Roelke. All present Council members voted aye; motion carried.







# Beresford Planning Commission April 10, 2023

The Beresford Planning Commission met in the Beresford City Council Chambers on Monday, April 10, 2023 at 6:30 pm.

Members Present: Chet Borah, Larry Bork, Brad Muller and Stan Peterson

Members Absent: Lenny Hofer

**Also Present:** City Administrator Jerry Zeimetz, Bob & Sharon Hustrulid, Mike Sveeggen, Bonnie Hybertson, Tom Diefendorf, Kendall Monson, Chris Hall, Tim Farley, Roger Schollerman, Woody Houser and Larry Anderson

Bork called the meeting to order at 6:30 pm.

**Minutes:** The March 10, 2023 minutes were approved on a motion by Peterson, second by Muller, all present voted aye.

# Public Hearings:

Request to rezone from Natural Resource Conservation District (NRC) and Single Family Residential District (R1) to Multi-family Residential District (R-2) Bak Tract 1 (1) of Freeman's Tract One (1) and Lot One (1) in the Southeast Quarter (SE ¼) of Section Thirty-Two (32), Township Ninety-Six (96), Range Fifty (50), City of Beresford, Lincoln County, South Dakota (Bak Brothers

Bork opened the public hearing. Zeimetz advised that signs were posted and property owners within 300 ft. were sent letters to advise of the request. The Bak Brothers have applied to rezone the property to Mult-family on behalf of the Beresford Housing Redevelopment Commission who have an agreement to purchase the property subject to financing and rezoning for a residential development that may include single-family detached dwellings, single family attached dwellings (town homes and duplexes) and multiple-family dwellings. Those attending were presented information about the housing project which could provide up to 50 new housing lots. Questions regarding access to the property via current public rights of way were answered. Zeimetz advised the Beresford HRC and City of Beresford applied for a grant thru the South Dakota Housing Development Authority in July of 2022 to assist with infrastructure improvements. As part of that grant request the property will need to be zoned properly to accommodate the residential development.

On behalf of the Beresford HRC, Tom Diefendorf the mix of housing that could be developed on the site. Funding may include a combination of grants, tax increment financing and donations.

With no more questions Bork closed the public hearing.

A motion was made by Borah, second by Peterson to recommend rezoning to the Beresford City Council to Multi-family Residential District (R-2). All commissioners present voted aye. Motion carried.

Bork opened the public hearing. Zeimetz advised that signed were posted and property owners within 300 ft. were sent letter to advise of the request. Woody Houser has applied to rezone the property from Multi-family residential (R-2) to General Business (GB) to expand the Windmill Campground.

Woody Houser was present and advise of his plan to expand the campground into the 4 acres he owns directly to the west of the existing campground. He is receiving request to accommodate larger units which he is unable to handle in the existing campground. He will follow all city and state regulations including infrastructure and access to the property.
