#### **ORDINANCE NO. 2021-10**

# AN ORDINANCE AMENDING TITLE 2, CHAPTER 2.02 SECTION 2.0201 OF THE BERESFORD CITY ORDINANCES AND DEFINING THE WARD BOUNDARIES FOR THE CITY OF BERESFORD

BE IT ORDAINED by the City Council of the City of Beresford, Union and Lincoln Counties, South Dakota;

That Chapter 2.02 Section 2.0201 of the revised Ordinances of the City of Beresford be amended to read as follows:

2.0201 Wards and Voting Precinct. The City shall be divided into three wards, which shall be combined and consolidated into one election precinct, and shall be designated respectively as Wards One, Two and Three. The wards shall be described by stating the certain street or avenue designations or other landmarks that divide and border the wards. Any reference to street or avenue below shall mean an imaginary line running down the approximate middle of each street or avenue. The wards of the City of Beresford are as set forth below and on the map thereof on file in the office of the Finance Officer. Any discrepancies shall be resolved by reference to the map rather than the physical descriptions set forth herein.

## Ward 1 shall consist of the following:


- That part of the City north of 298<sup>th</sup> St. between 3<sup>rd</sup> St. and NE 13<sup>th</sup> St. or 472<sup>nd</sup> Ave.
- That part of the City east of 4<sup>th</sup> St. and north of Birch St.
- That part of the City east of 5<sup>th</sup> St. and north of W. North Maple St.
- That part of the City **n**orth of Cedar Street except, the area west of 471<sup>st</sup> Ave and the area south of City right-of-way located one block north of W. North Maple St. and between N. 9<sup>th</sup> St. on the west and N. 4<sup>th</sup> St. on the east.

### Ward 2 shall consist of the following:

- That part of the City south of the City right-of-way located one block north of WN Maple St. between 9<sup>th</sup> St. on the west and 7<sup>th</sup> St. on the east
- That part of the City lying west of SW 13<sup>th</sup> St. or 471<sup>st</sup> Ave.
- That part of the City lying between Cedar Street on the north and W. Maple St on the south lying west of 7<sup>th</sup> St. except those portions west of 7<sup>th</sup> St. which are south of Elm St.

### Ward 3 shall consist of the following:

- That part of the City lying east of 7<sup>th</sup> St. and west of 4<sup>th</sup> St. and south of the City right-of-way located one block north of North Maple St.
- That area east of 8<sup>th</sup> St. and west of 7<sup>th</sup> St. lying between Elm Street on the north and Maple Street on the south
- That part of the City east of W. 13<sup>th</sup> St and west of 3<sup>rd</sup> St. lying south of Birch Street
